The stainless steel complies with the French national requirements regarding composition of stainless steel, as defined in "Arrêté du 13 janvier 1976 relatif aux matériaux et objets en acier inoxydable au contact des denrées alimentaires." the specification for stainless steel in the DGCCRF "Fiche MCDA n°1 (V02 - 01/04/2017) titled food contact suitability of metals and alloys".

### Migration analysis plastics

Samples of the product, or a similar product made from identical plastic material, have been tested for overall migration according to the test conditions specified in (EU) 10/2011 for repeated use, and the article comply with the overall migration limit of 10 mg/dm<sup>2</sup> or 60 mg/kg.

Test conditions for overall migration were OM3 (2 h at 70 °C)

Food simulants used for overall migration were 10 % ethanol (simulant A), 3 % acetic acid (simulant B) and olive oil (simulant D2).

Compliance with specific migration limits, and other restrictions, has been documented through testing, calculation or simulation.

Test conditions for specific migration was 30 min at 80 °C

Max ratio of food contact surface area to volume

The ratio of food contact surface area to volume that has been used to determine the compliance of the product:

1.8 dm<sup>2</sup>/100 ml

### Food contact types

The product is suitable for contact with the following types of food under the intended and foreseeable conditions of use:

- Aqueous
- Acidic
- Alcoholic
- Fatty
- Dry

Food contact usage time and temperature

Any food contact conditions up to 80 °C for 30 min

Non-food contact usage temperature

Minimum temperature: -20 °C  
Maximum temperature: 100 °C



## General

Equipment should be cleaned, disinfected and sterilised, as appropriate to its intended use, before use.
